#### ARTICLE V Amendments



The Chateaugay Railroad was created by the Chateaugay Iron Company in 1879 to build a narrow-gauge rail line from Lyon Mountain to Dannemora to move ore and charcoal for its iron-making operations. The line was extended to Standish in 1885, to Loon Lake in 1886, and to Saranac Lake in 1887. The Delaware and Hudson railroad financed the section to Saranac Lake, and then organized the dual-gauge Saranac and Lake Placid Railroad in 1890, opened in 1893; the standard-gauge section was run as a branch of the New York Central.

The D&H took control of the railroad in 1901, and in1903, combined the Lake Placid line with the main line as the Chateaugay and Lake Placid Railway, and converted the entire line to standard gauge. The Saranac Lake to Lake Placid section was sold to the New York Central in 1946, and finally abandoned in 1972.

### Positive Train Control Legislation

In the last issue of the *Form19* we told you about the dilemma facing the railroads because of the Rail Safety Improvement Act of 2008 that required them to have approved Positive Train Control systems in place and functional by December 31, 2015 or face substantial, crippling fines. The railroads across the country, including Amtrak, had been telling Congress that, although they had already invested nearly \$6 billion into the effort, they would not be able to meet the deadline and they were asking for legislation that would provide and extension of at least three years.

The Form 19 is pleased to report that on October 29th President Obama signed into law H.R. 3819, The Surface Transportation Extension Act of 2015. This bill was originated in the House Transportation and Infrastructure Committee, Chaired by Bill Shuster (R-Pa.), approved by the full House on October 27, and approved by the Senate on October 28.

The Act provides a blanket three year minimum with the additional provision that individual railroads can request a additional two year extension on a by case basis. That extension would be granted by the including rail passenger and commuter service patrons.

Now, one can be forgiven for thinking that this Surface Transportation Extension Act of 2015 is something that our Congressmen did to meet the needs of the railroads, their customers and the American public. Well, "sort of." You see the PTC portion of the bill was an add-on to the main feature of the bill – an extension of federal transportation funding of the Highway Trust Fund. This Highway Trust Fund funding was due to expire on October 31, thereby shutting down most highway construction and repair projects throughout the fifty states. This extension of this HTF funding is only good until November 20, 2015 by which time Congress will hopefully have worked out a two year plan for the extension of the Highway Trust Fund program.

The PTC portion of H.R. 3819 was identical to the language in H.R. 3763, the Surface Transportation Reauthorization and Reform Act of 2015, passed October 22 by the House Transportation and

Infrastructure Committee. The language of this bill was acceptable to Senator John Thune (R -S. Dak.) who is Chairman of the Senate Commerce Committee, which has the responsibility of presenting such bills to the full Senate for approval. Sen. Thune and Rep. Shuster had been working in coordination to extend the PTC deadline but they both realized that introducing this effort separately would not be viable, i.e., Congress might ignore it without additional motivation. Thus the PTC effort became "SEC. 1302. ENSURING SAFE **TRAIN IMPLEMENTATION** OF **POSITIVE** CONTROL SYSTEMS" ofThe Surface Transportation Extension Act of 2015.

The original PTC legislation of 2008 had as its motivation the prevention of accidents of passenger trains and any freight trains that transport toxic chemical that would present an inhalation hazard if released. As reported in the last issue of the Form19. the railroads had, individually and as an association, told their customers that they might shut down completely or at a minimum not transport any extension of the completion date to December 31, 2018, chemicals that might be considered a toxic inhalation hazard. Indeed, some railroads had stated that they would no longer accept such items for transport after December 15 with the intention to clear cars with such Transportation Secretary. That big, collective sigh that material off their property by the end of the month. The you heard on the 29th was the collective response of all American Chemistry Council (ACC) had filed a lawsuit the railroads management, employees and customers, in federal court to stop the railroads' planned service embargo on certain toxic chemicals. After the law was passed and signed, the ACC released a statement commending House and Senate leadership "for recognizing the urgent need to address the PTC issue". This group, the ACC, estimated that a one month shutdown of rail service would cost the U.S. more than \$30 billion dollars, lead to 700,000 lost jobs, and lead to such things as municipalities being unable to treat their water.

> Heaven knows how much this issue has cost the railroads (in addition to the billions already spent) nor how much other industries and businesses have spent to address the possibility of a shutdown, but it certainly seems that a lot of people considered this threat real.
