

Trains Along the Mohawk

As I woke up on the morning of October 17th it was a cool, damp morning, having rained the day before and into the night. The sky however was now clear, and the sun started to peek out in the east. It looked like it was shaping up to be a bright, sunny Fall day. I was delighted, as this was our Hudson Berkshire train watching day.

The location for our HBD meeting was along the Mohawk river at Lock 10 near Amsterdam NY. This turned out to be a great location for watching trains with a bright blue sky, some colorful fall trees, and an open view. What better way to spend a beautiful Fall morning and early afternoon?

I arrived just before 10 AM to find I was not the first one there, Chuck Haley and Ed Skowronek had gotten there just before me, just in time to catch their first train of the day. I missed it by minutes, as they say "a day late and a dollar short. "Oh well, the day was still young. We parked our cars right along a gravel road next to the river and soon after more of our members started showing up, including Ed O'Rourke from Syracuse NY. Ed is the Western Area Director for the Northeastern Region of the NMRA and it was great to have him join us. It was not long before we had a line of parked cars and chairs spread out on the lawn socializing, at a safe distance of course, waiting for our first, well for most of us, train

to pass by. Just like clockwork, at 10:05 here comes an eastbound oil train with two CN units to start us off.

As time ticked by our president Irwin Nathanson thought it might be a good time for a quick meeting. This sounded good. Besides you know how things work, as soon as you start doing something -- that's when a train will show up. As it turned out we just finished our meeting and -- bam -- here comes our 2nd train of the day: BNSF # 8511 in the lead followed by CSX #5 pulling another oil train at 12:15 PM. Right after that, 12:18 PM, an eastbound Amtrak # 702 passenger train. Followed by a westbound gravel train CSXT # 484 at 12:39. At 12:48 we had a CSX Hi-Rail truck also heading west, maybe it was trying to catch CSXT # 484...good luck with that! This was turning out to be a rather good train watching day!

Next came another westbound train with CSXT # 3147 and CXST 172 in front and CSXT # 3083 mid-train DPU at 1:25 PM. This appeared to be two trains, the first half was all containers and the second half UPS and FEDEX TOFC. Wow, we barely had time to talk, but we did manage to get a few laughs in here and there!

This looked to be like the last train of the day for us and most of our members were calling it a day. A few of us hung around just to finish talking and to say our goodbyes. Wait... what's that... yes! Another train, CSXT # 3205 and # 709 auto train at 1:41 pm. Not too bad if I say so myself!

Hi everyone! Since it still isn't wise for us to meet indoors, and it's getting too cold for us to meet outside, your Hudson-Berkshire Leadership Team has been looking for what other options might be available. For November, we're going to try holding a live virtual meeting. I will be hosting the meeting on Google Meet, which is a service similar to Zoom or Webex, and Irwin will be presenting his clinic. You'll be able to join the meeting from any computer, tablet, or smartphone with an Internet connection, and there is no fee or signup required. There's also no software to install; the meeting will run right in your web browser.


A few hours before the meeting starts, a link for the meeting will be sent out via Constant Contact, and the link will also be posted on the main page of hudson-berskhire.org. Simply follow the link and you'll be brought to the meeting. If you're already signed in to a Google or Gmail account, you'll be brought into the meeting immediately. If not, you'll be prompted to enter your name. You may also get a notification asking for permission to use your camera or microphone.


Simply follow the prompts and you'll be brought into the meeting. You might need to wait a minute to be accepted, but once you are, you're all set. I'll start allowing people into the room around 15 minutes before the meeting starts.



To access the chat, click the bubble icon in the top right corner of the screen, and then type your message in the box that appears.

We all know it has been a very trying year for all concerned - family, friends and those in our community. It has been the goal and tradition of the Division each year to purchase train sets and donate them to the Marine Corps "Toys For Tots" program for which they are very appreciative. And we ask that they, the Marines and the volunteers, distribute these train sets during their "northern" convoy from Albany north so that the children that happen to reside in our Division's footprint receive these train sets.

We all know we had to cancel this year's Great Train Extravaganza - the Division's main source of funds. And each year we designate a portion of that revenue to the Division's dedicated Toys For Tots fund. In addition, in the past, we have held raffles during the course of the year at monthly Division meetings with the proceeds going into the that fund - but we all know that didn't happen this year except for the kind donations members made at the September meeting at Thatcher Park and for that we are very grateful!

Bottom line - the balance in our Toys For Tots Fund this year is just shy of \$400. Last year we bought 18 train sets which cost us around \$1300 (about \$68 per train set) - thanks to Paul Werschler at JP Trains who gets the sets for us at a discount and generously, over the years, has covered the cost of the shipping - for which we are extremely grateful.

We would like to this year at least purchase 10 train sets - *and are asking for your help*. We feel somewhat hesitant in asking for your help as we all appreciate what you have all done for the Division over the course of your membership: helping with the GTE, hosting Division meetings, doing presentations at Division meetings, volunteering at the Pacemaker Convention back in 2016, submitting material for the Form 19, volunteering your time for other Division activities, serving in a Division leadership position, and the list goes on and on....

So, since the upcoming annual Train Shows, GTE and Springfield have been canceled - how about donating a portion of the money you would have spent there to the Division's Toys For Tots fund! Layout Ideas

About a dozen years ago I was gathering ideas for a new layout in a new home in upstate NY. The house would be of new construction and I wanted it to be "model railroad friendly." Having a son in the building trades provided a ready consultant and my own 65 years in the hobby offered plenty of background experience to draw upon. To begin, my wife and I decided it would be single story for ease in our "mature years." We wanted a basement for storage and room for mechanicals but NOT for a layout. My wife said she had liked to hear trains running in the back, 12 x 18-foot room of our N.J. home. My 12" to 18" wide shelf pike in that room circled the walls. I think this also created a sense of "family inclusiveness" in the evenings since it avoided my disappearing into a basement or attic. Family members could conveniently pop in at any time to view what I was building or talk.

Another reason for not building in the basement was continued temptation it would present to expand further. While this is certainly not true for everyone, I wanted to be sure that it would not happen—especially since I was closing in my 70s and I had a variety of other interests of which I was equally fond, as did my wife. However I will readily agree that a basement layout can be very comfortably cool in summer and equally pleasant in the winter.

Having decided on a "main level layout," where should I place it? That was easy—right next to the garage! Machine tools like a table and chop saw, drill press, grinder, disc sander, etc. were just steps away. I'm definitely obsessive about NO sanding, filing, cutting, etc. with machine tools in my train room after the benchwork was up! Dust, if not enemy #1 of a model railroad, is close to the top of the list! To keep dust out of the train room, I had twin pocket doors installed. They are kept closed when I'm not in the room. I was also considering creating a positive pressure environment in the room by having a small fan placed in the wall fronting the hallway. I envisioned the fan to draw filtered air into the train

room. After further consideration, I did not do this, instead planning to use a portable ionic air cleaner or two in the train room. Even before considering this, I made what I believe to be most critical decision for a "happy railroad room." This was the installation of radiant, under the floor heating for the whole house. I well knew the short comings of forced hot air heat, especially if you have pets in the house or are subject to allergies. Oil or gas fired hot water or steam radiators I suspect would be equally effective in keeping a dust free environment, but my research sold me on radiant heat. It avoided the potential issue of where to place radiators.

Putting the RR room at the garage end of the house made it easier to bring lumber and building material directly in from the garage. In fact much of could be cut to size or length without coming into the house. Also, this made it unnecessary for RR friends to walk through the house when visiting the layout. A utility bathroom with a wash basin and tub was located right across the hall from the layout room for convenience of guests and well as cleaning up paint brushes and scenery materials.

There was another advantage to the layout room having a common wall with the garage. As a youngster, I was fascinated when passing through the industrial district of Passaic, N.J. where the Erie RR's Dundee Spur served many industrial buildings. Several of them had sidings entering the buildings. Watching Erie (later Erie Lackawanna) engines placing and removing cars from these building was too intriguing not to model. Using thin "profile" buildings, I pierced the wall for a three car siding to enter a model steel, structural fabrication plant. On the other side of the wall (garage side), I built a simple box enclosure to contain the siding. This keeps garage dust and cold air from entering the layout room. The "roof" of this "containment" easily lifts off if necessary to rerail cars. A piece of foam rubber (not visible) serves as a safety bumper in case an engineer is careless in placing cars.

A final point—rather than dealing with the issue of windows in the room, I had "ghost windows" installed in the rough framing. These will accept standard size windows to make the room suitable for another purpose. A stud finder will locate horizontal frame members.

Joe Kavanagh and I have been working on an Interlocking Tower in 1.5" scale for the Adirondack Live Steamers. It will be placed, next spring, at the entrance to Broadway Yard. Joe is building the outside in his usual fashion of magnificent workmanship, and I have been modeling the necessary furniture for the second floor. Here are some photos of our work so far.

An outside stairway will go up on the opposite wall, and the building will probably be painted yellow and brown to match our clubhouse. We plan to have interior illumination.

The levers are copied from the Saxby & Farmer mechanical interlocking system used for so many years in interlocking towers across America as well as the rest of the world.

In addition to the levers, I have also modeled a desk, chair, several tables, a track plan which mounts over the levers, hanging from the ceiling, and several other small items including a clock, calendar, first aid kit, telephone, and typewriter.
